# Alumni Spotlight



Patrick Mullane graduated from the University of Scranton in 2010 with a major in Criminal Justice. Patrick joined the New York City Police Department in July of 2010 and currently is a Sergeant in the Intelligence Bureau. Patrick previously served in the Midtown South and Midtown North Precincts as well as the Harbor Unit and Training Bureau. Patrick graduated from the Naval Postgraduate School's Center for Homeland Defense and Security in March of 2020 with a Master's Degree in Homeland Security.

Sgt. Mullane serves on the board of the Michael Mulhall Foundation which is a charity that aids families with special needs children. The foundation

was founded in memory of Michael Mulhall (Scranton 10') who tragically passed away in a car accident. Michael was on his way to work were he served as a camp counselor for children with special needs.

Patrick is married to Meredith Truesdale Mullane (Scranton 10') and they have a one-year-old daughter Mackenzie. Patrick described how the Criminal Justice program at Scranton provided him with the proper tools to start a career in law enforcement and prepared him to succeed in graduate school.

### Faculty

**Dr. Meghan Ashlin Rich** has published an article with Dr. Nicole King of the University of Maryland Baltimore County entitled: "Building Together in Baltimore?' Corporate Mega-Development and Coalitions for Community Power" in the journal Urban Affairs Review (2021). This article was based on Drs. Rich and King's two years of extensive qualitative research on a multi-billion waterfront development project and the community benefits agreement the developer and city made with the surrounding racially segregated communities of South Baltimore. Dr. Rich is currently collecting data in New Orleans during her sabbatical year, studying pandemic (and Hurricane Ida) effects on arts and cultural production in the city.

Dr. Sinchul Back moderated the 2021 White Hat Conference hosted by Boston University and the Department of Justice's Bureau Justice Assistance. He also published a preliminary edition of a book titled Digital Forensics and Cyber Investigation. Also, his research paper, "Cyber Place Management and Crime Prevention: The Effectiveness of Cybersecurity Awareness Training Against Phishing Attacks" has been published in the Journal of Contemporary Criminal Justice. His manuscript entitled "Malware Infections in the US during the COVID-19 Pandemic: An Empirical Study" has been published in the International Journal of Cybersecurity Intelligence and Cybercrime. Dr. Back published a research paper titled "Journey to Cybercrime and Crime Opportunity: Quantitative Analysis of Cyber Offender Spatial Decision Making" in the International Journal of Computer and Information Engineering. Dr. Back recently presented a paper titled "Routine Activities Theoretical Perspective: A Case Study of Colonial Pipeline Ransomware" at the European Society of Criminology Conference.

Dr. Mehmet F. Bastug was named to the 100-member Certified Ethical Hacker Hall of Fame by the EC-Council, the International Council of E-Commerce Consultants. Founded in 2001, the EC-Council is the world's leading global cybersecurity certification body. The 2021 Hall of Fame celebrates some of the most accomplished Certified Ethical Hackers (CEHs) around the world. Dr. Bastug has recently published two opinion articles, Rethinking Cybersecurity After Colonial Pipeline Hack and Cyber Evolution of Terrorist Groups at Orion Policy Institute. He also co-authored an article, Fear of Terrorism and Fear of Violent Crimes in the United States: A Comparative Analysis, in Crime and Delinquency with Dr. Ismail Onat.

*Dr. Michael Jenkins* was recently elected to serve on the Board of Directors for *Cypress House*, which focuses on serving the needs of individuals returning from prison and their families. Their inaugural program—a bakery run by people who were formerly incarcerated—will be modeled on Fr. Greg Boyle's *Homeboy Industries*, based in Los Angeles. Dr. Jenkins is also a newly-elected member of the executive committee for the board of directors of *Alpha Sigma Nu*—*The Jesuit Honor Society*.
